## Competition Terms and Conditions – iGolf May Sign-Up Prize Draw

1. The iGolf May Sign-Up Prize Draw (the “**Competition**”) is open to all individuals who sign-up for an annual iGolf subscription in the month of May 2025, excluding employees and their immediate families of England Golf, its affiliated companies, their agents, or other persons professionally connected with the Competition.
2. The Promoter is The English Golf Union Limited, trading as England Golf, with Company Number 05564018, and whose registered address is The National Golf Centre, The Broadway, Woodhall Spa, Lincolnshire, LN10 6PU (the “**Promoter**”).

### How to Enter

3. To be entered into the Competition, an individual (the “**Entrant**”) must follow the steps outlined in clause 6 below.
4. The Competition is open between 00:01 (local UK time) on 1<sup>st</sup> May 2025 until 23:59 (local UK time) on 31<sup>st</sup> May 2025 (the “**Competition Entry Period**”).
5. An Entrant may make one Valid Entry. All entries exceeding this will be void.

### How the Competition Works

6. In order to make a “**Valid Entry**” the Entrant must:
  - a. Sign up for an annual iGolf subscription during the Competition Entry Period, such sign-up being subject to the “iGolf Terms & Conditions” published by the Promoter from time to time; and
  - b. Opted in to receive communication from England Golf during signup process throughout the Competition Entry Period.
7. For the avoidance of doubt, only individuals who sign up for a brand new annual iGolf subscription shall be eligible to make a Valid Entry. iGolf Subscribers who renew their annual iGolf subscriptions within the Competition Entry Period shall not be eligible to submit an entry to the Competition.
8. Automatically generated survey submissions and submissions via agents or third parties are invalid and will not be counted.

9. Any entries not meeting the criteria set out in these terms shall be invalid. The Promoter will not be liable for entries which are not received or corrupted for any reason, and the Promoter will not be liable for any errors or inaccuracies contained in entries.

### Prize Draw and Winners

10. All Valid Entries received by the Promoter during the Competition Entry Period will be entered into a random prize draw.
11. The winning entry (the "**Winner**") will be chosen in a random draw comprising all Valid Entries.
12. The draw will take place within two weeks after the end of the Competition Entry Period, and the Winner will be chosen from all Valid Entries received during the Competition Entry Period.
13. Following the selection of a Winner, the Promoter will contact the Winner using the email address supplied on the Winner's iGolf Sign-Up form with information on how to redeem the Prize.
14. The Winner must confirm their acceptance or rejection of the Prize within 14 days of being notified of the result of the draw.
15. If the Winner does not accept the prize within 14 days of being notified of the result of the draw, or if the Winner rejects the Prize, or if the Promoter deems the entry is invalid or in breach of these terms, the Winner's Prize will be forfeited and the Promoter may at its sole discretion select another Winner in accordance with the procedures set out above.
16. The Promoter's decision is final, and no correspondence will be entered into.

### Prizes

17. The prize ("**Prize**") is:
- a. 1x FootJoy Voucher – Redeemable for one pair of FootJoy Premiere Series shoes.

19. The Promoter accepts no responsibility for any costs associated with accepting and redeeming the Prize including but not limited to transport, additional accommodation, or food and drink. All costs associated with redeeming the Prize are the responsibility of the Winner.

## Data Protection

- 20.** Except as is provided for in these terms, personal data will be processed in accordance with the Promoter's Privacy Policy which can be viewed here: [Privacy policy - England Golf](https://www.englandgolf.org/privacy-policy) (<https://www.englandgolf.org/privacy-policy>).
- 21.** In these terms, "**Personal Data**" means the Entrant's full name, the Entrant's email address, the Entrant's postal address, the Entrant's telephone number(s), and any photographs, videos, and/or audio recordings of the Entrant supplied to the Promoter by the Entrant.
- 22.** By entering into the Competition, the Entrant is deemed to have consented to the following processing activities relating to the Entrants Personal Data:
- a. The Promoter will process the Personal Data for the purposes of administering, arranging, or organising the draw, selecting a Winner, communicating with the Winner, delivering or arranging for the delivery of the Prize, or for purposes ancillary to that;
  - b. The Promoter may publish the Winner's first name and county of residence on its social media profiles;
  - c. The Promoter may request photographs of the Winner and/or the Prize, and if the Entrant supplies the Promoter with photographs, the Promoter may publish those photographs on its social media profiles;
  - d. The Promoter may disclose and/or transfer the Personal Data of the Winner to third parties for the purposes of administering, arranging or organising the Prize, or for purposes ancillary to that, and in such circumstances Personal Data may be processed by these third parties in accordance with their privacy policies; and
  - e. The Promoter may contact the Winner(s) to obtain feedback on the Competition and the Prize.
- 23.** The Winner may withdraw consent for processing by notifying the Promoter in writing following acceptance of the Prize.

## General

- 24.** By submitting an entry into the Competition, the Entrant is deemed to have agreed to these terms and conditions.
- 25.** Any reference to "written" or "in writing" shall include postal communications sent to the Promoter's registered address and emails sent to the following address ([igolf@englandgolf.org](mailto:igolf@englandgolf.org)) but not fax, SMS text, direct messages over social media, or any other form of written communication.

- 26.** While nothing in these terms and conditions will limit or exclude the Promoter's liability for death or personal injury caused by its negligence or for fraud, the Promoter will not be legally responsible to Entrants or Winners for any losses that were not foreseeable to the promoter or to the entrant at the time of entry to the promotion or which are caused by a third party.
- 27.** The Promoter reserves the right to cancel or amend these terms at any time without prior notice in the event of circumstances out of the Promoter's control. The Competition may be amended, withdrawn, or cancelled at any time at the Promoter's discretion.
- 28.** These terms will be governed and construed in accordance with the laws of England and Wales and is subject to the exclusive jurisdiction of the English courts.
